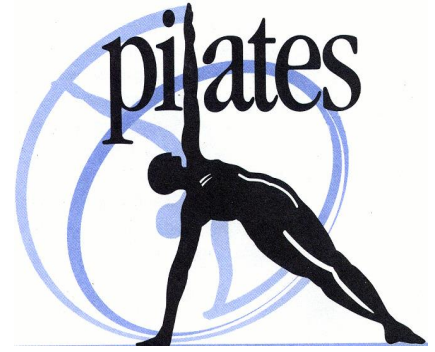


# Pilates Mat Class
