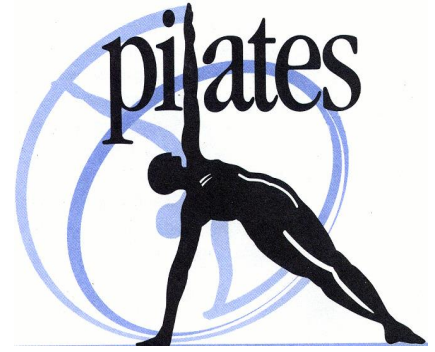


Pilates Mat Class
