## 2) URBAN RENEWAL PLAN AND BLIGHT STUDY

- Jill Gallant from VHB reviewed and presented the Uban Renewal Plan of the Uotown Area of the Village of Port Jefferson for the Board of Trustees and the Public.
- Mayor Garant commented on the Housing Issues and Recommendations concerning Work Force Housing per page 11 of the report.
- Trustee LaPointe questioned if there was a way to incentivize condominiums.
- Trustee Miller asked Attorney Egan if the Village could Zone for Condos. Village Attorney Egan responded that the Village cannot zone for ownership type.
- Mayor Garant commented that there is no single use office space, but incentivizes mixed use.
- Mayor Garant also commented that the Village was not looking use Eminent Domain but the village is reserving its use as a tool to help the village and give us options.
- John Koehnlein 341 Thompson Street questioned determines if a building has to be "re-done". Mayor Garant responded that the Village cannot force the current owner to revitalize its building; we would work with a master builder to revitalize the entire area.
- John Koehnlein further asked about the percentage of low income housing. Mayor Garant responded that per page 11 of the report 10 % of new rental or for-sale units are deemed to be Workforce Housing, but there is no requirement for low income housing.
- Don Pawluk Sr 7 Corie Ct, Questioned whether Rail Realty had affordable Housing Requirement. Mayor Garant responded that it had no requirement per its funding with the IDA.
- Motion by Mayor Garant second by Trustee LaPointe to close the Public Hearing concerning Urban Renewal and Blight Study at 8:00PM.
