NOTICE OF RESOLUTION ADOPTED SUBJECT TO PERMISSIVE REFERENDUM

NOTICE IS HEREBY GIVEN that the board of Trustees of the Village of Port Jefferson, at a regular meeting thereof, held on November 5, 2018, duly adopted the following resolution subject to permissive referendum:

BE IT RESOLVED, that

WHEREAS, Article 12-A of the Town Law prohibits the establishment or extension of an "improvement district" in an Incorporated Village without consent of the Village expressed in local law, ordinance or resolution, subject to permissive referendum; and

WHEREAS, Article 12-A of the Town Law includes in the definition of an "improvement district" an ambulance district in any Town; and

WHEREAS, it is in the best interests of the residents of the Incorporated Village of Port Jefferson, to obtain quality and reliable ambulance services; and

WHEREAS, it is the intent of this resolution to facilitate the extension of the Mount Sinai Ambulance District in the general vicinity of the Incorporated Village of Port Jefferson and Belle Terre and the Hamlet of Mount Sinai, Town of Brookhaven with the cooperation of all residents and parties; and

WHEREAS, it is the intent of this resolution to express the consent of the Incorporated Village of Port Jefferson to the extension of the Mount Sinai Ambulance District in the general vicinity of the Incorporated Villages of Port Jefferson and Belle Terre and the Hamlet of Mount Sinai.

NOW, THEREFORE, be it resolved that the Incorporated Village of Port Jefferson, does hereby consent to the extension by the Town of Brookhaven of the Mount Sinai Ambulance District in the general vicinity of the Incorporated Villages of Port Jefferson, Belle Terre and the Hamlet of Mount Sinai provided, however, that the aforesaid district shall include the Incorporated Village of Port Jefferson, in its entirety.
