# Instructions for: SEASONAL OUTDOOR DINING PERMIT APPLICATION

Pursuant to Code of the Village of Port Jefferson §250-58

A complete application shall consist of the following:

- 1. Application Fee (\$200.00 for new applications, \$100.00 for renewals) per §250 Attachment 1:1 Table of Fees
- 2. Permit Fee- \$100.00 per table per annum upon approval
- 3. Three (3) hard copies of Application and Certificate(s) of Occupancy/Certificate(s) of Existing Use
- 4. Three (3) hard copies of floor plan including indoor table locations, indoor space adjoining entrances/exits
- 5. Three (3) hard copies of current survey with scaled layout of location and proposed outdoor dining area and access to outdoor dining
- 6. Color photographs of the area to be converted to outdoor dining and existing dumpster location (new applications only)
- 7. Original Signed and Notarized Owner's Endorsement form if applicant is other than the owner. If ownership is held jointly or in partnership, each owner and/or partner must sign a separate owner's endorsement.
- 8. Disclosure Affidavit

Upon submission of a complete application, the Board of Trustees will schedule it for a public hearing. Public hearings are required for all new applications and, at the discretion of the Board of Trustees for renewals. The procedure and requirements are outlined below:

a) An applicant is required to notify the surrounding property owners no later than ten (10) days prior to the hearing. A list of all property owners within a 200 foot radius from each corner of the property or within a distance of five lots from the property line(s) whichever is the greater distance must be prepared and submitted by the date of the hearing. The list must be prepared from current tax records of the Village of Port Jefferson or of the Town of Brookhaven.



## Instructions for Seasonal Outdoor Dining Permit Contd.

- b) Posters, not more than 200 feet apart along the street line of the property which is the subject of the application, not less than 24 inches by 36 inches in size, must be conspicuously posted along the entire length of each street frontage of the property which is the subject of the appeal at least 10 days prior to the date set for the public hearing before the Board of Trustees. The applicant shall pay a fee of \$25 for each poster. Posters are available at the Building and Planning Department, 88 North Country Road. Such poster(s) shall contain the following information:
  - (1) The current zoning and the proposed use (Seasonal Outdoor Dining)
  - (2) That a public hearing will be held before the Board of Trustees at a specified date, time and place with regard to the proposed application.
- c) After the applicant has mailed the notification letters and posted the PUBLIC NOTICE signs on the property, the applicant shall submit an Affidavit of Mailing and Posting with attached photograph of posted sign and proof of mailing to the Village Clerk. A copy of this Affidavit is enclosed within this package.
