#### **ZONING BOARD of APPEALS**

Proposed installation of double-sided, internally illuminated freestanding signs: Catholic Health et al (shown on site plan dated 1/11/22 revised 3/17/23)

- 1) Main Entrance: Sign #PE-8 002: Area: 3'-7" x 8'-0" = 29 sq. ft.
- 2) ER Entrance: Sign #PE-8 003: Area: 3'-7" x 8'-0" = 29 sq. ft.
- 3) ER Entrance: Sign #PE-8 004: Area: 3'-7" x 8'-0" = 29 sq. ft.
- 4) Myrtle Ave./ OP Entrance: Sign #PE-8 007: Area: 3'-7" x 8'-0" = 29 sq. ft.

Where a freestanding sign is proposed, a minimum setback of 5'-0" from any property line is required, and where the proposed sign is to be located at the interior side of the easterly property line and therefore, results in no setback (0'-0") from the property line:

*Village of Port Jefferson Code § 250-31F(1)(b):* 

Freestanding signs and monument signs, including directory signs.

[4] Such freestanding sign shall not be erected nearer than six feet to any building nor encroach on any required side yard and shall be set back not less than five feet from all property lines.

The public hearing opened at 6:30PM.

Present: Philip Butler c/o Farrell Fritz P.C., Angela Kowalewski, Traffic Engineering Technician c/o R&M Engineering & Jim O'Connor, President of St. Charles Hospital.

P. Butler presented the application followed by a presentation by A. Kowalewski and a staff report by R. Harris.

Exhibit 1: R&M Engineering "sign placement evaluation and site distance analysis".

Mr. O'Connor spoke regarding addressing the Board's concerns and ensured that the hospital will remove the necessary bush in front of ground sign PE-8-002 located along Belle Terre Rd as a condition.

The Board reviewed the five criteria of an area variance.
